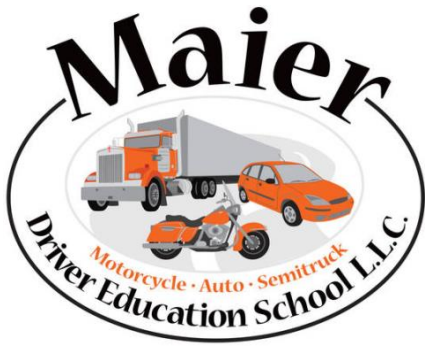
RE: DRIVER EDUCATION RULES

The following is a summary of the State Regulations and Maier, LLC Company Policy:

1. State Law requires a minimum of 24 hours of classroom instruction for Segment 1. **NO EXCEPTIONS. Class starts promptly at scheduled time.** Because of the importance and condensed nature of the class, this rule will be strictly enforced. You will be able to get into the next class offered only if there is room. State guidelines mandate a minimum of 24 hours of classroom instruction for Segment 1.

The State of Michigan mandates that students have a minimum of 6 hours behind the wheel (BTW) training with an instructor. Students will also complete a minimum of 4 hours of observation of other drivers as required by the State of Michigan.

2. The student will be graded separately on classroom and behind the wheel (pass-fail), and **THEY MUST PASS BOTH!**
 3. Students **must** pass with a minimum of 70% of all classroom required work and State Exam.
 4. Students **must** come to class prepared – pen or pencil, paper, and any worksheets/materials issued by the instructor.
 5. No student will be allowed to participate in Driver Education sessions if the teacher has reason to believe that said student is impaired resulting from usage of alcohol and/or drugs. Instructors need to be informed of any medical condition that might impair the student's driving and be informed of any medication that the student may be under while driving.

6. School dress code applies to the Driver Education Class.
7. Students will be sent home if their behavior is improper or if hygiene affects the class/drives.
8. You must show up at the time you are scheduled to drive to avoid additional charges.
9. Students must realize that they will be far from expert drivers after finishing this class and they will need many hours of driving after this program before they could be considered an experienced driver.
10. In conclusion, we would like to remind both the student and the parent(s)/guardian(s) that **VEHICLE CRASHES ARE THE NUMBER ONE CAUSE OF TEENAGE DEATH.**

PARENTS and GUARDIANS, you have the legal right to contact the Secretary of State in writing at any time and have your son's/daughter's license revoked until their 18th birthday.

The Segment 1 Registration Form and Contract can be filled out the first night of class or parents/guardians can go online to our website www.driversedmi.com to download a copy and print to bring to the first night of class.

We expect students to take this program seriously. Disruptive behavior in the classroom and/or the car will NOT be tolerated and can be grounds for dismissal from the class.
