COURSE PROVISIONS

Maier, LLC will provide a minimum of 6 hours of classroom instruction provided by a certified instructor. Classroom instruction shall not exceed 2 hours per day.

REQUIRED DEPARTMENT OF STATE INFORMATION

Notice- This provider is required to be certified by the Secretary of State. If you have any complaint, which you cannot settle with this provider, write: Michigan Department of State, Driver Programs Division, Lansing, MI 48918. Completion of driver education instruction does not guarantee qualification for a driver license.

For a student to participate in Segment 2, verification must be received via driving log that the student has completed a minimum of 30 hours of driving (including 2 hours at night) with a licensed parent or guardian (or parent designee) on a Level 1 License, which has been held for not less than 3 continuous months.

TERMS

1. The parent or guardian agrees to pay the amount of \$ ____ which needs to be paid in full on the first scheduled day of class. The parent/guardian and the student will be jointly liable for this agreement in the full amount even if the course is not completed.
2. State certificate will be held until payment is received. There will be a \$30.00 charge for non sufficient funds.
3. Dropping this course must be approved in advance by Maier, LLC. (See refund policy below)
4. Student must complete all quizzes and homework to successfully pass this course
5. I understand that it is important that my teen attend all classroom sessions. Students will not be admitted to the classroom more than 15 minutes late and will be required to make up the classroom session at a subsequent session in order to receive credit towards completion of Segment 2.
6. Additional Behind-the-Wheel driving instruction may be purchased as required for \$40.00 per hour, sold only in two-hour packages.
7. A fee of **\$25.00** will be assessed if certificate needs to be replaced for any reason. There are two options for replacing a certificate: (1) Parent may come to Maier, LLC office to pay fee by cash or money order and receive new certificate the same day, OR (2) Parent may send check or money order by mail to the office and certificate will be mailed out when check clears.
